- 1.2 Body shell: 4-door touring car body shell brand **RD Logics** only.
 - 1.2.1 Front bumper must follow the body contour and be made of foam rubber.
 - 1.2.2 The body shell must be made from flexible plastic material and painted, window to be clear.
 - 1.2.3 Hole cutting.
 - Ventilation holes, maximum 65 mm on the front windscreen and maximum 70 mm on the rear windscreen.
 - Optional hole 55 mm for refueling gun is permitted.
 - Only front side window can be removed.
 - Glow plug access hole, maximum 15 mm.
 - Antenna and exhaust opening are permitted but should not be bigger then require to exit the body shell.
 - 1.2.4 Tail wing, no part of it should be above the roofline of the body.
- 1.3 Weight: 1,650 grams minimum (without fuel and transponder).
- 1.4 Engine capacity: 0.12 size or 2.11 capacity engine (open).
 - 1.4.1 Fuel tank: 75 cc. with no loose inserts inside the tank.
- 1.5 Fuel: Nitro Fuel no limitation on percentage%.
- 1.6 Tires: Sponge tires brand **Cross** only.

1.7 Brake: Only single braking system working on the central power transmission, no

multi or individual wheel braking is permitted.

1.8 Drive transmission: Maximum 2 speed gear box with de-clutching device

permitting the engine to run while brake is applied.

1.9 Frequency Crystal: Drivers are required to bring more than one sets of crystal.

1.10 Protrusion: Protruding antenna must collapse under the weight of the car and

should not be use to turn the car upright in the event if the car were to turtle up. All body post must not protrude beyond 10mm above the

body.

1.11 Weather: In the event of adverse weather condition, the organizer will decide

the numbers of rounds for heats. Racers are advised to prepare their cars for wet race. Race event will pause upon interruption by rain. Race will resume once the rain stops where starting position is

determined by the last standing before race paused.

Competition Etiquettes

Punctuality

- All participants are requested to abide strictly to the time schedule so to avoid delays to the starting time and finishing of the race.
- The Race Director will start off the race regardless of the absent of certain drivers at the time of the race event.

Radio frequency

- Participants must be aware at all time the frequency of their transmitter.
- Participants may not change their registered frequency without clearance from the Race Director.
- When transmitter is being remove from the compound area it is the responsibility of the participants to ensure that it is not turn on until it is their turn to race.
- No transmitter can be removed from the compound area without the permission of the compound official.
- In the event if the race is being held up due to frequency interference cause by irresponsible participants, the Race Director have the right to disqualify the participants from further race.
- Participants are reminded to bring extra sets of crystal to facilitate changing of frequency in the event when there is a clash of frequency within the racing group.

Racing

- Participants must at all time follow the instruction given by the Race Director.
- Back marker must give way for lead cars to pass or will be told to by the Race Director.
- No car should be repair on the track during the race, mechanic or assistance will have to remove the car to the side of the track to perform the tusk.
- Pit crew must be instructed to remove the car from the pit lane when refueling and placing the car back on the pit lane and not on the fast track.

 Participants who display incompetence control of their car will be ask to quit the race.

Dispute

- In the event when there is a dispute, the Race Director will make the decision and past judgment.
- Should the party concern is not satisfy with the outcome he can request to forward the matter to the Jury of the race. The Jury is made up of participants selected by the organizing committee and officials from the organizing committee. The decision by the Jury is final.

The above Car Technical Specification and Competition Etiquettes are the current guideline for the race. Suggestion to enhance the above criterion is most welcome. Request will be subject to approval by the organizing committee. All requests must be make in writing and submit to the organizer.
